**Waiver, General Release,  
Arbitration and Indemnity  
Agreement**

Specifically to induce you to permit our child(ren) to attend the class, I/We, on behalf of ourselves and our child(ren), hereby irrevocably agree as follows: to waive and release you, any other instructors you may use and the owners(s) of the aforesaid premises from and against any and all liabilities of any nature whatsoever that otherwise might be deemed to arise out of or be referable to our or our child(ren)'s presence on the aforesaid premises, or attendance at the class and/or the lessons, other than liabilities exclusively attributable to your or such other instructors or owner(s)'s gross negligence or willful misconduct; that the total amount of any such liabilities shall be limited to and shall not exceed the amount we have paid to you on account of our child(ren) attending the class; and that any and all issues arising out of or referable to this matter shall be resolved exclusively by arbitration in Orange County, California in accordance with the then prevailing commercial rules of arbitration of the American Arbitration Association, unless and except to the extent that your liability insurer, if any, opts out of arbitration, and , instead, opts for judicial proceedings; to indemnify and hold you, such other instructors and such owner(s) harmless from and against any liabilities, costs, fees and expenses, including, without limitation, legal fees and expenses, except to the extent otherwise heretofore specifically provided for; hereby waives the provisions of section 1542 of the Civil Code of the State of California, which provides as follows: "A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor;" and that I/we possess full legal right and authority to enter into this agreement on behalf of each and all the foregoing persons.
